

CHAPTER I

INTRODUCTION

1.1. Background of study

Consciousness and connotation, conceptual meaning and association, and the position of words; by Balabanis and Stathopoulou (2021:56). In accordance to Jos Daniel Parena, the category of meaning includes the theory of referential correspondence, the theory of concepts, the theory of spiritism, or the theoretical and conceptual formalism, Jaenudin and SennyAlwasilah (2018).

Semantics is a branch of linguistics that focuses on meaning by Papafragou (2021). In this study, the writers examined the contextual meaning “Semantic analysis the songs of Ata Ratu”. Word meaning is a topic that deals with the relationship between words and meanings (Bahodirovna n.d.). It also deals with denotation, connotation, synonyms, antonyms, antonyms, homonyms, homonyms, polysemy, and figurative language (Triana et al. 2022).

Adilah And Rahmadani (2022) stated A lyric is a literary expression of a person about something he has seen, heard or experienced, typically words and language. Lyrics have the form of messages in the form of written words and sentences by Asrifan (2021) that can be used to create a certain atmosphere and imaginary image for the listeners so that they can also create various meanings.

A song is a composite of music and lyrics by Naseri (2022). Tonality and rhythm in regular speech can augment the production of musical sounds with the voice by Jiam and Limb (2020). Singers were then referred to as a singer or
