CHAPTER 1

INTRODUCTION

1.1 Background

Humans behavior can be observed or seen, while the soul is a part of humans that cannot be seen but is reflected through their behavior. This makes humans an interesting object to study. therefore at a branch of science has emerged that specifically studies humans and their psychology, namely psychology.

Psychoanalysis is the study of human mental behavior (psychology dictionary). Every human being has a variety of behaviors. Humans have three mental systems namely id (pleasure), ego (actions, behavior) and superego (morals, ethics, values, parents) Freud in Hall (1954). It can be assumed that human nature and behavior are carried out on the basis of unconscious motives or on the basis of thoughts, feelings, tend to act unconsciously and partly unconsciously. The essence of studying psychoanalytic science is that we can find out how human character or our selves are when doing something unconsciously or how human behavior is when experiencing problems. Every human being has different problems.

In addition, Freud described there are three divisions of the human psyche, namely the id, ego, and superego (Freud in Minderop, 2011: 21-23). The id is a psychosocial energy and choice that pressures humans to fulfill their basic needs. The ego is the main leader in personality, the ego that makes decisions about the difficulties faced by himself. While the superego refers to the moral in personality, which is able to distinguish between good and bad.

Every human being has a different character. Klarer (2004:17) defines the term character usually denotes a personal with more complex and differentiated features. Characters are the persons represented in a dramatic or narrative work, who are interpreted by the readers as being endowed with particular moral, intellectual and emotional qualities by inferences from what the persons say and their instinctive ways of saying it the dialogue and from what they do the action. The grounds in the characters' temperament, desires, and moral nature for their speech and actions are called their motivation.

This character can also be found in the film Layangan Putus and the film series "The World of The Married". Layangan Putus is a serial film from Indonesia produced by MD Entertainment directed by Benni Setiawan. This film premiered for the first time on November 26, 2021 on WeTv and iflix, and the second broadcast on February 9, 2022. Meanwhile, The World of The Married is a drama series originating from South Korea, produced in 2020.

Researcher is interested in researching the Layangan Putus and The World of The Married because these two films have the same plot namely household problems. Researcher is interested in examining the main characters of the two film because the main character are always present in every story. The researcher have describe the psychology of the main character in the films Layangan Putus and The World of The Married because the researcher saw psychological problems or mental conditions that were influenced by the id, ego and superego in the main characters of the drama series. The researcher uses the theory of psychoanalysis to analyze the character or personality of the main character in the serial Layangan Putus and The World of The Married, because this theory put forward by Freud divides the personality system into three structures, namely the id, ego and superego that always exists within every human being and affects his character. Also, the researcher have compare the characters of the main female and male characters to see the similarities and differences related to the id, ego and superego.

Based on the background described, the researcher is interested in taking the title of this study with the title "A Comparative Study Between Main Characters of Layangan Putus and The World Of The Married Serial Movies Using Sigmund Freud's Psychoanalytic Theory"
