ABSTRACT

A sign (according to the structuralist view) is then defined as being such a pair (signifier, signified), This theory was put forward by Ferdinand De Saussure (1857-1913). This study aims tofind out the symbol and meaning of the Tebe Likurai Dance, The Formation of Tebe Likurai, and The function of the Tebe Likurai Dance. The research methods used is qualitative. Data was collected through interviews. The results of the study show that Tebe Likurai has two meanings, namely Haliku and Rai. Haliku means supervise, guard, protect, maintain, take, and master. Rai Means Land, Earth, Country, or Island. There are 3 types of dance movements namely, First, Wesey wehali (Winding like a zig-zag). Second, tebe re (The thunderous jolt from right to left.) Third, be tae be tae to ba lutuhun (bow your head at the time dance.) and The form and meaning of Tebe Likurai Dance namely. Circle, Semicircle, Triangle, Straight Line, Parallel lines, and V-shaped. The Function of Tebe Likurai, Entertaining, Matchmaking, Unity, Art Value, and Glorifying God. This research is expected to be a reference for future research.
